I further hereby **AGREE TO INDEMNIFY AND HOLD HARMLESS THE RELEASES** from any loss, liability, damage, or costs, including court and attorney fees, that may incur due to my participation in said activity, **WHETHER CAUSED BY NEGLIGENCE** or otherwise. It is my express intent that this Release and Hold Harmless Agreement shall bind the members of my family and spouse if I am alive and my heirs, assigns, and personal representative, if I am deceased, and shall be deemed as a **RELEASE, WAIVER, DISCHARGE AND COVENANT NOT TO SUE** the above-named **RELEASES** IN SIGNING THIS RELEASE, I **ACKNOWLEDGE AND REPRESENT** THAT I have read the foregoing Waiver of Liability and Hold Harmless Agreement understand it, and sign it voluntarily as my own free act and deed and based upon no representation that is not contained herein. I

execute this Release for full, adequate and complete consideration fully intending to be bound by the same.

I hereby consent to receive medical treatment that may be deemed advisable in the event of injury, accident, and/or illness during this event and acknowledge understanding that I am responsible for any charges or financial obligations arising from such treatment.

I understand that at this event or related activities I may be photographed. I agree to allow my photo, video, or film likeness to be used for any legitimate purpose by the event holders, producers, sponsors, organizers, and/or assigns.

I voluntarily elect to participate in this activity with knowledge of the danger involved, and I hereby agree to accept and assume any and all risks of property damage, personal injury, or death.

I, the undersigned participant, affirm that I am at least 18 years of age and am freely signing this agreement. **I have read this form and fully understand that by signing this form I am giving up legal rights** and/or remedies which may otherwise be available to me regarding any losses I may sustain as a result of my participation. I agree that if any portion is held invalid, the remainder will continue in full legal force and effect.
